long with Hospice professionals across the country, Lake Sunapee Region VNA & Hospice is on a mission to learn how to better serve Veterans who are facing challenges from illness, isolation or traumatic life experience. It may surprise many people to learn that 25 percent of those who die every year in the U.S. are Veterans. As part of its "Living Hope Umbrella" program, and to help provide care and support that reflect the important contributions made by these men and women, Lake Sunapee Region VNA & Hospice (LSRVNA) has become a national partner of We Honor Veterans - a pioneering campaign developed by the National Hospice and Palliative Care Organization (NHHPCO) in collaboration with the Department of Veterans Affairs.

We Honor Veterans focuses on respectful inquiry, compassionate listening and grateful acknowledgment. America's Veterans have done everything asked of them in their mission to serve our country. LSRVNA believes that it's never too late to give them a hero's welcome home and is stepping up to acquire the necessary skills to fulfill our mission to serve these





men and women with the dignity they deserve. The We Honor Veterans campaign provides tiered recognition to organizations that demonstrate a commitment to improving care for Veterans. "Partners", working with NHHPCO and local departments of Veterans Affairs, can assess their ability to serve Veterans and integrate best practices of care for Veterans. "By recognizing the unique needs our nation's Veterans may be facing during chronic or life-limiting illness, we are able to accompany and guide our service men and women and their families to a better quality of life. Identifying, listening to, and working along side veterans with the support of this program will also help facilitate meaningful closure at end of life," says Betsy Wotton, RN, CHPN, BSIS, LSRVNA Hospice Program Director. "They were there for us, and we want to be there for them."

One of only two home care organizations in New Hampshire to have done so, Lake Sunapee Region VNA & Hospice has achieved "Partner Level I" status in the We Honor Veterans program and was recognized as such at the November 10th NHHPCO Conference.

"Partner Level I" Requirements:

- Provide Veteran-centric education for staff and volunteers and identify patients with military experience.
- Conduct a minimum of three different Veteran-specific presentations for administrative, clinical staff and volunteers within your organization.
- Review "Military History Checklist and Guide" with staff and volunteers.
- Integrate the "Military History Checklist" process into agency referral procedures.
- Identify the designated Hospice and Palliative Care contact person at closest VA medical center and/or Community Based Outpatient Clinic.



IRA Charitable Rollover Reinstated for 2011

The IRA Rollover was first enacted in 2006 as part of the Pension Protection Act and remains available in 2011, allowing individuals aged 701/2 and older to donate up to \$100,000 from their Individual Retirement Accounts (IRAs) to public charities without having to count the distributions as taxable income. Since the provision was first enacted, Americans have contributed millions of dollars to worthy non-profit organizations around the country. Distributions can only be made to a qualified charitable organization and must be transferred directly from the IRA trustee to the charity. Colby-Sawyer College Students Breathe Life into Capstone Project

Senior nursing students Tanis Fico, Lyndsay French, Melissa Quinn and Gina Sanford are creating a "Toolkit" as their Senior Capstone Project which will help to enhance the role of nurses in referring patients to Hospice Care, particularly patients with chronic pulmonary disease. What is the role of the nurse in referring patients to Hospice? How can the "Toolkit" educate nurses and offer ways to have meaningful conversations with patients about end-of

life options and wishes? Only about 50% of eligible Medicare patients actually enroll in Hospice care, with few of these diagnosed with chronic pulmonary disease. It is far more likely that persons with cancer will be referred to Hospice than those with pulmonary conditions. Through key informant interviews and other means, the students are researching demographics of who enrolls in Hospice and how they were referred. They are also learning about the barriers to referrals, some of which were expected but some that have been quite unexpected. Partnering with Dartmouth Hitchcock Medical Center, the students have had the unique opportunity to see pulmonary patients in the ICU first-hand, many of whom who are clearly eligible for Hospice. Do these patients know about and understand the criteria for and benefits of Hospice? "For us, it's a wake-up call that we need to better address this issue" said Lyndsay French. Results of their research will begin to form the "Toolkit", which will be available for use by Lake Sunapee Region VNA & Hospice in the Breath of Hope component of its "Living Hope Umbrella" program, a program that refines care based on specific diagnoses such as pulmonary disease.

"We couldn't be happier about the enthusiasm of the Colby-Sawyer Senior nursing students in developing the "Breath of Hope" component of our *Living Hope Umbrella* Program. Their insight is invaluable and, with the education and experiences of the Colby-Sawyer College program, it is certain these eager young nurses will be entering the field with a jump-start" said Betsy Wotton RN, Hospice Program Director.


